The year of 2019 witnessed many fundamental events that played an important role in the movement of trading regionally and Globally. Global stock markets registered their best year since the financial crisis, as investors ignored U.S-China trade tensions, fears of a hard Brexit and warnings of slowing growth in major economies. The S&P 500 index of top US companies has risen 29% in 2019, signaling a series of record highs, as Trump's tax cuts, share buy-backs and optimism about growth prospects in the United States boosted markets. In addition, Stocks rose as soon as it became clear that the US central bank was backing away from higher interest rates. Actually, the Fed suddenly reversed course by cutting the interest rates, and also began expanding its balance sheet again. Eurozone stocks outperformed, with French CAC adding 26% followed by the German DAX advanced by 25%. The Athens Stock Exchange was the best-performing European stock exchange. The Athens General Index (ATG) has risen nearly 49% during the year of 2019. In Asia, Shanghai Composite index had its best year since 2014, China's index ended the year up 22%, in addition, Japan's Nikkei 225 rose 18%, supported by the possibility of new incentives by the government of Shinzo Abe. The MSCI World index, which measures stocks across the developed world, jumped nearly 24% during 2019 - the strongest performance since 2009. On the other hand, MSCI Emerging Market Index was lower by 16%.

The International Monetary Fund (IMF) cut its forecasts for 2019 and 2020 in October, citing limited ammunition for central banks to tackle the slowdown and impact of the trade war between the United States and China. The IMF revised the MENA region's growth forecast for 2020 in tandem with decline in the global growth forecast. The global economic growth forecast for 2020 was reduced 0.1% to 3.4%. MENA region's growth forecast was reduced 0.4% to 2.7% for 2020 mainly due to downward revisions in most GCC sovereigns. Oman's growth forecast was reduced the most, by 2.5% to 3.7%, followed by Saudi Arabia, which witnessed a 0.8% downward revision to 2.2%. Growth forecast for Saudi Arabia, the GCC region's largest economy, was reduced by 0.8% to 2.2% for 2020, a pick up from 0.2% expected growth in 2019. Low growth forecast for 2019 was attributed to declining contribution from oil GDP following the extension of the OPEC+ agreement. Extension of production cuts, coupled with geopolitical tensions in the country, would affect Saudi Arabia's economic growth as its energy sector represents ~50% of GDP. Among GCC peers, only Kuwait witnessed an increase in its growth forecast for 2020, which was increased by 0.2% to 3.1%.

MENA markets ended the year of 2019 with a mixed performance. GCC Indices (Except Oman) were the best performer, led by Kuwait Bourse which advanced by 24% followed by Saudi market increased by 20%, Dubai Financial Market rose by 9%, and last is Abu Dhabi Securities Exchange which increased marginally by 3%. On the other hand, Muscat Securities Market was the worst by -8%.

The Dubai Financial market (DFM) General Index Increased by 9% to close at 2764.86 at the end of 2019 compared to 2529.75 points at the end of 2018. The index reached its highest level last year on September 3rd at 2951.55 point, whereas the lowest level last year reached 2475.51 during the trading session on the 12th of February 2019. In addition, Abu Dhabi Securities Exchange (ADX) General Index advanced marginally by 3% to 5075.77 point at the end of 2019 compared to 4915.07 point at the end of 2018. The index reached its highest level last year on April 23rd at 5426.25 point, whereas the lowest level reached 4670.97 during the trading session on the 19th of May 2019.

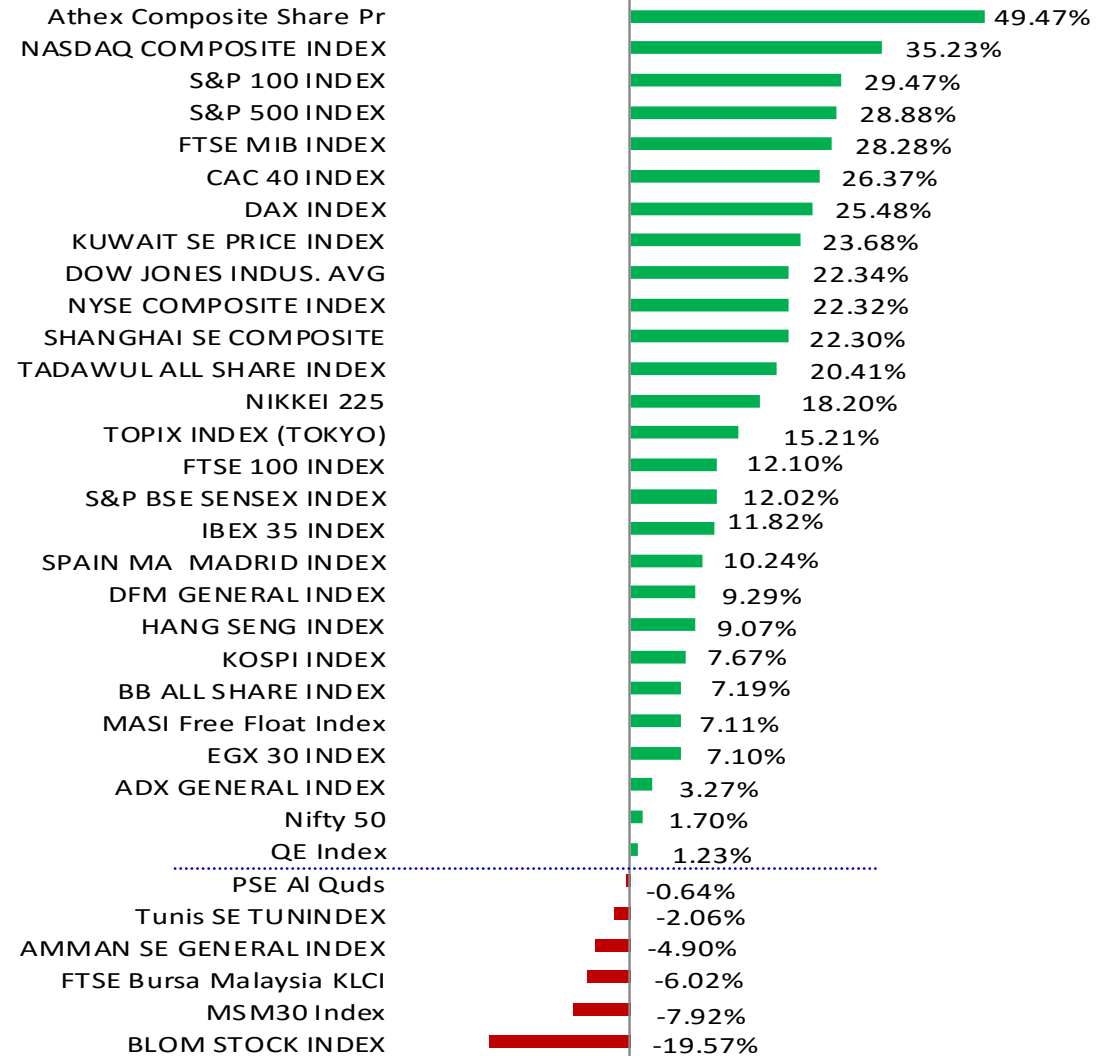
At the sectorial level, three sectors out of nine represented on the DFM ended the year in the red, The Consumer Staples has the worst sector which decreased by 20%, followed by Services sector declined by 12% then Real estate by 10%. On the other hand, Banking Sector was the best performers which surged by 27%, followed by Insurance Sector by 22%, Telecommunication Sector by 10%, Industrial by 9%, Transportation Sector by 8% and 7% for Financial and Investment Services.

Four out of the nine sectors represented on the ADX ended the year in the green territory, In contrast to the Dubai market, the consumer sector surged by 99%, followed by the Real estate sector by 30%, then 6% for both banking and Services sector . The Financial and Investment Services sector has the worst sector which decreased by 51%, Industrial sector is the second decreased by 21% , followed by Insurance sector which fell by 12% and Telecommunication and Energy sector which declined by 4%, 2% respectively.

At the end of 2019, the market capitalization for UAE Markets Advanced by 7% amounting to AED 908 billion compared to AED 851 billion at the end of the 2018. Banks , Telecommunication and Real Estate acquired around 84% of the total Market Cap in UAE Markets. The value of shares traded during 2019 reached AED 110 billion compared to AED 99 billion recorded in 2018 increased by 11%. The number of shares traded declined by 8% to reach 55 billion shares during the year of 2019 compared to 60 billion shares traded in 2018 . The number of transactions executed during 2019 increased by 12% to reach 1.04 million compared to 0.93 million deals carried out during the year of 2018.

Global Index Performance in 2019

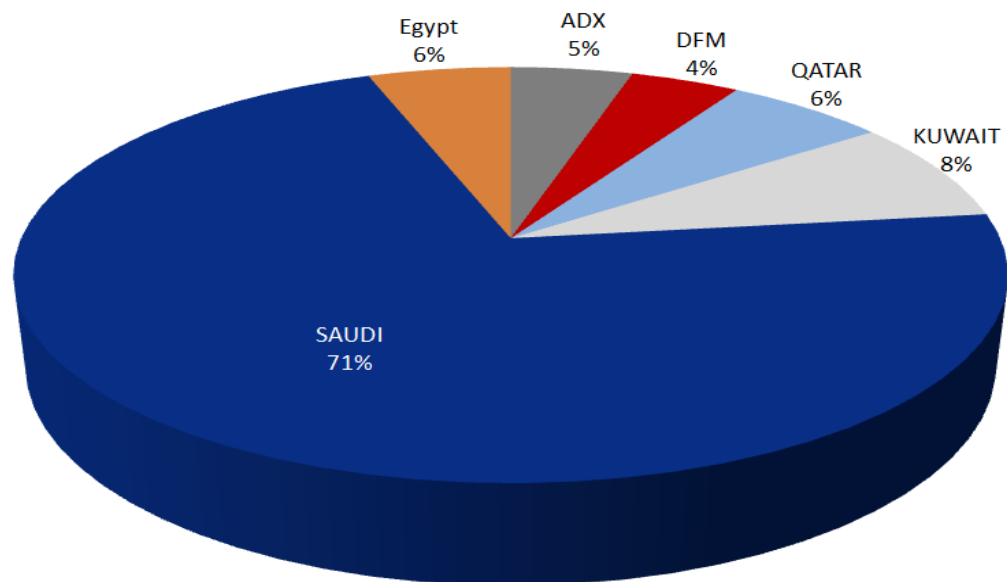


At the regional level, UAE markets came the second amongst the MENA markets under coverage in traded value for the year of 2019, accounting around 9% of total traded value in the GCC and Egyptian stock markets.

Trading values for Kuwait, UAE and Saudi Arabia advanced by **↑92.4%**, **↑8.6%**, **↑1.1%** respectively, while Qatar and Egypt declined by **↓6.4%** and **↓16.1%** respectively.

Total traded value on these markets collectively amounted to US\$ 325.5 billion compared to US\$ 312.5 billion in 2018, a decline of **↑4.2%**.

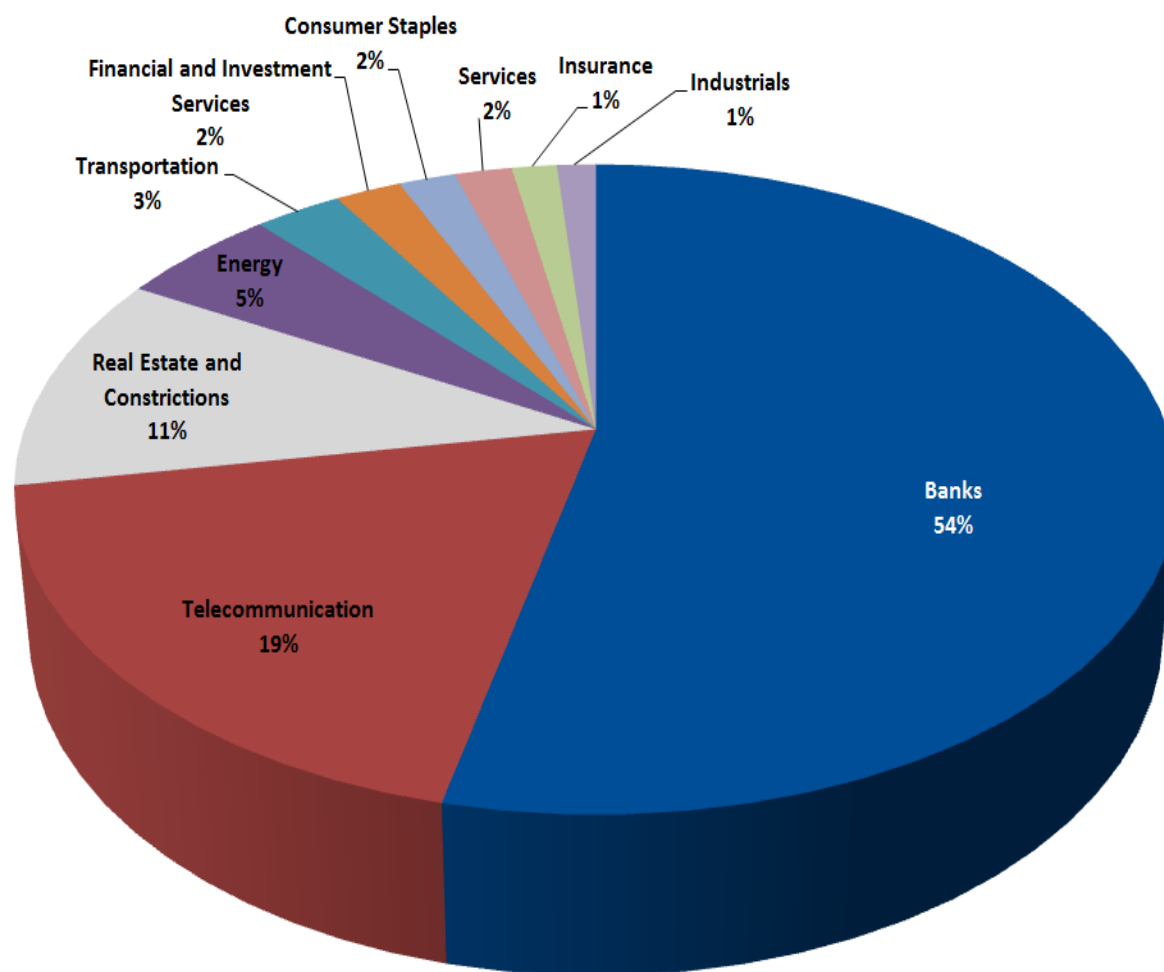

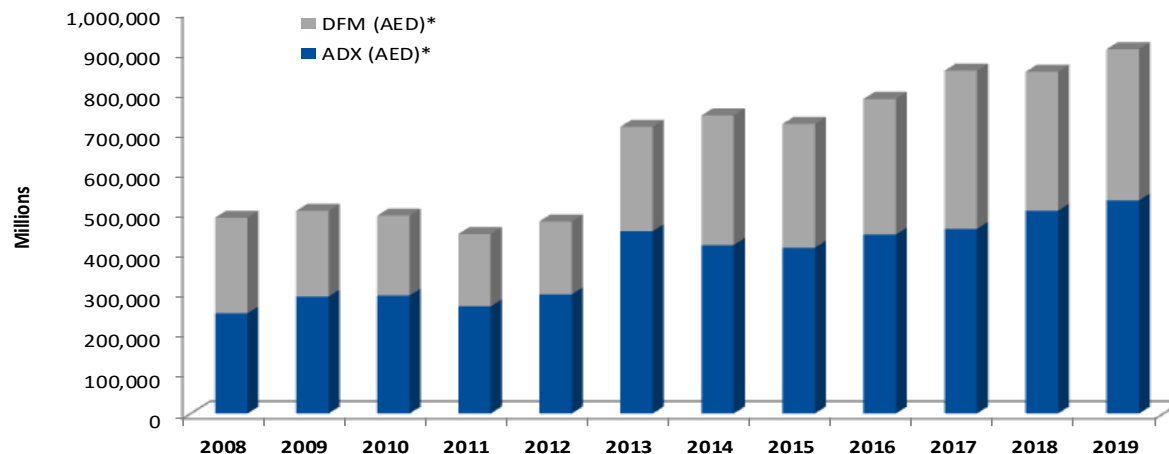

As for the sectors' contribution to Market Cap, the **Banking** sector ranked first in both UAE markets to reach AED 481 billion , or 53.6% of the total Market Cap, the **Telecommunication** sector ranked second to reach AED 167.6 billion or 18.7% of total market cap, followed by the **Real Estate and Constrictions** which contribute AED 97.7 billion or 10.9% of the total Market Cap. Thus, these three Sectors acquire around 83.2% of the total Market Cap.

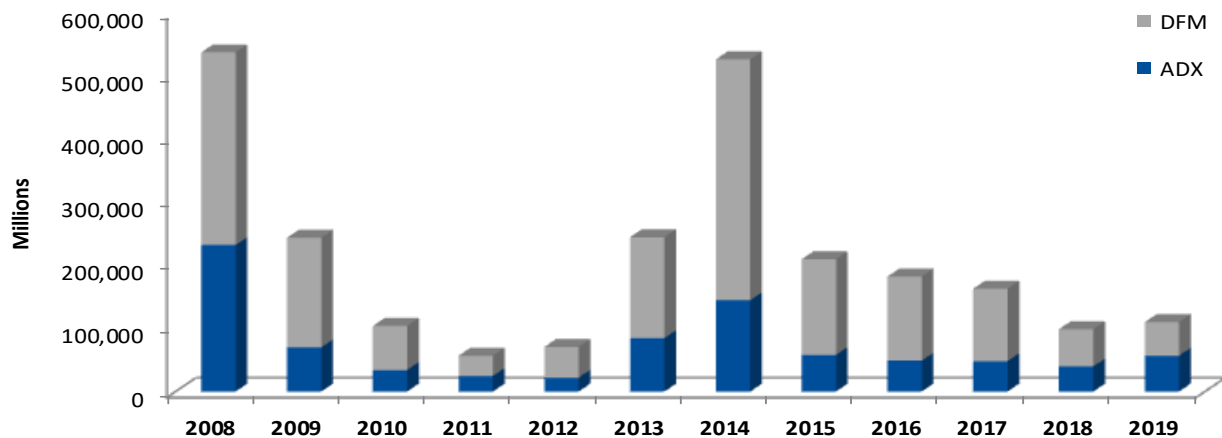
Market Cap for UAE Indices from 2008 till 2019
